Kevin motioned to approve the minutes of the October 25 meeting. NBC seconded and all were in favor.

### **Director's Report:**

January presented the financial reports of the **Director's report** for the month of October. The financial reports were filed for audit.

January highlighted various aspects of the narrative section of her monthly report. She noted that:

- The Youth Services department is conducting a special program titled *1,000 Books before Kindergarten*. Participants will read one book a day for three years to their children to achieve the goal of the title.
- Virtual meetings continued to take place for the library's upcoming ILS migration.
- The Adult Services Department held 57 adult programs that 755 people attended.
- The Youth Services Department held 41 in-house programs that 1,288 people attended.
- Various staff members participated in the Rutgers Graduate School of Education Library Literacy Class visit on October 30.

#### **President's Report:**

Nick compiled a comparison of selected budget metrics between FTPL and SCLS titled A Tale of Two Budgets that he sent to board members prior to the meeting via email.

Note 1. Franklin Library works on a fiscal year, 07/01 thru 06/30, but this is the actual amount spent from 01/01/2022 - 12/31/2022.

Note 2. 2022 actual expenditures, as reported in the SCLS introduction of their 2023 budget. Costs of operating nine branch library buildings are **not** included and are paid for by the host municipalities. The SCLS uses space at the Bridgewater Library, and pays Bridgewater for it.

Building operating costs include maintenance, repairs, utilities and insurance. Capital cost of buildings and land are not included.
